


Mr. Bennett has prepared CLE presentations on the following topics:

A grievance filed against an attorney can be an intimidating, frightening experience for any attorney and Thomas Watkins, who is a former member of the Commission for Lawyer Discipline, estimates that every new attorney licensed after 1999 will have at least two disciplinary complaints filed against them during their career.

2. What the Texas Attorney Should know about the State Bar of Texas, Texas Lawyer Assistance Program (TLAP)

The State Bar of Texas TLAP Program is designed for Texas Attorneys, Law Students, and Judges who have signs and and symptoms of Depression and Substance Abuse. You can call TLAP any time of the day or night at 1-800-343-8527. 32% of Lawyers 30 years of younger have a Drinking Problem. 28% of all lawyers struggle with some level of Depression. 19% of lawyers demonstrate symptoms of Anxiety and 11% of attorneys have had Suicidal Thoughts. All callers to the Help line can remain confidential by statute.

Mr. Bennett is a member of the SBOT TLAP
Committee and has spoken to Law Student Groups
and how to develop programming to raise awareness
about alcohol and peer assistance. Young Lawyers
are taught how to maintain a healthy life style. All
lawyers can find help not discipline and fulfill an
attorney's ethical obligation to report. TLAP helps
aging attorneys deal with specific issues, including
loss of cognitive abilities. Judges are helped with
issues related to substance use or mental health
disorders and maintains a list of volunteer judges who
interested in providing support to peers in crisis. The
